













The Recovery, Social Reconstruction and Resilience Plan reflects the interest of the countries to take advantage of the potentialities of the regional integration space to elaborate a synergy instrument that helps mitigate the effects of the pandemic and provides the opportunity to shape societies that are more resilient, more socially fair and more environmentally sustainable. The preparation of the has the commitment and support of the del Programme of the European Union for Social Cohesion in Latin America-EUROsociAL+; and the advisory of the Food and Agriculture Organization of the United Nations (FAO), the International Labor Organization (ILO) and United Nations Human Settlement Programme (UN-Habitat).

Objetive

"Articulate responses from the public sector to social, labor and territorial ordering of human settlements and urban development problems of the member countries of SICA with a perspective of regional integration, in the social and economic reactivation phases post-COVID"

The intervention areas are:



1) Social Protection



2) Employability and employment



3) Informal Settlements and sustainable urban development

Articulation with the regional interventions in the 3 areas of intervention:



a) the Regional Integral Social Policy 2020-2040 (PSIR-SICA) and the Regional Intersectoral Agenda on Social Protection and Productive Inclusion with Equity 2018-2030 (ARIPSIP).



b) the Regional Action Plan of the Council of Ministers of Labor of Central America and Dominican Republic (CONMINTRAB), on priorities in labor issues.



c) the Regional Action Plan for the Implementation of the NUA in the SICA region (PRINAU-SICA 2020-2036) of the CCVAH, and the Regional Policy for Gender Equality and Equity (2015-2025), (PRIEG/SICA), promoted by the COMMCA.

The Plan is configured as a social policy instrument to face the post-emergency derived from the pandemic that is complemented with the PSIR-SICA 2020-2040 and the regional sectoral Agendas.























SCOPE AND CHARACTERIZATION

The Plan is made up of a defined set of projects that Will respond to the 3 areas of intervention with identified prioritization in the fast consultation processes, carried out at a national, multi-country and/or regional level. The projects Will help to attract and align resources, in favor of the social recovery in the region.

The projects must:



Facilitate the reactivation and recovery, while creating conditions for the resilience in the 3 areas of intervention.



Stimulate the ownership by the countries and be able to bring together public, private, and civil society organizations (national or multi-country) around them.



Articulate regional and national interventions and promote the intersectoriality



Favor structural reforms and be oriented towards sustainability.



The Plan is **linked to the** objectives and goals that cover the economic, social environmental spheres of the 2030 Agenda and the SDGs and aims to help the countries to stay in the path towards achieving the goals set in the referred global agenda.
